The planned period for saving your data

 obligated to save the data for a longer period based upon retention obligations related to tax or commercial
 law (according to the German Commercial Code, the German Tax Code or the German tax rules and
 regulations);
- If the processing is based upon your consent, the data are saved for the term of this agreement.
